

# DISCHARGE OF LIABILITY – FOR MINORS

OCEANMAN POLIGNANO A MARE 2019

## 1) FOR THE PHOTOGRAPHIC AND VIDEO SHOOTING OF THE EVENT AND THE USE OF THE PARTICIPANT IMAGE.

Registering a minor, I/we grant, in the name and on behalf of the same, the release for the use of his/her image in the terms described below, attesting under my/our full responsibility to have parental or legal authority over the minor or in any case to have been previously authorized, by the persons who have this authority, to grant the release for the use of his/her image.

I/we read and approved the Rules for the Participation at the Oceanman Polignano a Mare event - as well as the Privacy Policy - and I/we acknowledge that his/her registration and / or participation constitutes a free and independent choice. With the same registration and/or participation in any capacity, I/we expressly authorize ASD Otrè Triathlon Team (Event Organizer), directly or through their service partners, to shoot video and photographs of my image in the context of the Event and the consequent use of the same images for purposes related to the documentation of the Event by any means and through any channel or support, digital (tv, internet, etc ...) or analogical (newspapers, posters, brochures, etc).

I/we also authorize Nuonet Gestìon S.L. to the eventual marketing of the photo and video services of the Event through the digital platform RockTheSport.com of its property (through which online registrations are collected and on which will be inserted those collected directly by the organization), including its Internet site and its possible App, with the consequent offer, free of charge or for a fee, of the photos and videos, for private use only, to all the participants (not minors) and to the subjects authorized by them.

The authorization is intended to be granted - according to articles 10 of the Civil Code and 96 and 97 of Law no. 633/1941 (Copyright law) - free of charge, for the whole world and without time limits, always not exceeding the limit of protection of minor's dignity, and with the faculty for the Organizer to authorize the sponsors and technical and service partners of the Event to use the mentioned images for the same purposes that are subject of this authorization.

## 2) FOR PHYSICAL FITNESS.

According to the Italian D.M. (Ministerial Decree) of 18/02/1982 and subsequent additions, containing the "Regulations for the health protection of competitive sports activities" that require to "those who practice competitive sports to undergo before and periodically to the control of the specific fitness health for the specific sport (...) that they practice":

I/we, undersigned holders of parental/legal authority over the registered minor, declare, under my/our own responsibility that:

- the minor is a good swimmer, is in good health and therefore he/she has not psycho-physical contraindication to swim the expected distance;
- the minor is in possession/or will be in possession of a medical certificate/declaration – valid the day of the event - attesting his/her ability to participate at a long competitive swimming race (*obtained by carrying out expected medical examinations*);
- the minor is therefore physically able to participate at the OCEANMAN POLIGNANO A MARE fixed on Saturday October 05<sup>th</sup>, 2019 and Sunday 06<sup>th</sup>, 2019 and of which we all accept the Rules;
- the minor doesn't have any illness, with particular reference to cardio-circulatory problems, and he/she doesn't use drugs.

## 3) FOR THE DISCHARGE OF CIVIL AND CRIMINAL RESPONSIBILITY.

I/we, undersigned holders of parental/legal authority over the registered minor:

- declare that the organization will not have any civil and penal responsibility for any material, physical or moral damages, direct or indirect, that could occur to the minor or that he/she could cause – by him/ or by family/friends – to persons and/or things, before, during and/or after the event, both in the water (due to negligent and/or anti-sporting behavior and/or due to lack of respect of national and regional aquatic rules) and in event area and in parking area;
- declare that the organization will not have any responsibility for any accident caused by negligence, inefficiency or low reporting; we declare that nothing will be charged or requested (by us or by our family) in case of accident or death occurring to the minor during the event.
